1. Welcome & Apologies

2. New Trustees

Sheena thanked all the Trustees for our commitment and hoped that the work we do would continue to support the local communities. The group wished to record their gratitude for Sheena's efforts but acknowledged that she hadn't taken this decision lightly and there were several reasons for her reaching this decision.
