SM pointed out that with the invoice for this years' floral decoration expected to be in the region of £650-£750 this would take the expenditure above that threshold.

GK advised that we would need to arrange for new signatories and for the accounts to be audited. CD would make the necessary arrangements.

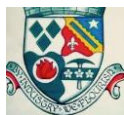
